More than **25 million** children in Europe are at risk of **poverty and** exclusion



More than half the world's children – **1.2 billion** – live in countries affected by widespread poverty, conflict and discrimination

More than 45% of children in Romania and Bulgaria, and more than 30% of children in Spain and Italy are at risk of poverty or social exclusion



Girls face double discrimination due to their age and gender.

- Each year, **12 million** girls are married before the age of 18.
- 32 million primary school-aged girls worldwide do not attend school



Migrant and refugee children face social exclusion and are denied access to basic social services.



Outside of Europe, **1**in **6** children live in
conflict settings. Many
of these children are
victims of violence and are
increasingly targeted in
conflict, including at school.



Hundreds of thousands of children in Europe are confined to harmful institutions due to poverty, disabilities or discrimination, even though 80% of them have a living parent and could grow up in the care of families and communities.



Children in fragile countries are among those who will feel the **biggest impact from climate change**. European children will also be affected.

The EU has been a principled aid donor, defender of rights and champion of sustainable development. It must continue this legacy now, more than ever, to defend and protect children's rights at home and abroad and to ensure a sustainable future that leaves no child behind.

BREAK the cycles of poverty. inequality and conflict for future generations

By intervening early, we can break these cycles and empower children through education. social services and strengthened child-care and child protection systems.

The EU has a role to play in stopping the war on children bevond its borders by ensuring they are protected. and by recognising and supporting children as actors of peace.



INVEST in children inside and outside Europe

Investing in children is the best way to break these cycles and invest in everybody's future. Healthy, educated, resilient children lead to more prosperous. sustainable, stable and safe societies.

This investment is not iust about monev. It also means ensuring that rights-based and sustainable policies are adopted to create the Europe children need.



LISTEN to children's voices. INVOLVE them in decisions affecting them and ACT on children's views

Even though children are the future of Furope and have valuable opinions, we do not listen to them enough.

Politicians are accountable for decisions they take that affect children MEPs must listen to children and involve them in decisions that affect them. They must act on children's views and take responsibility for decisions that impact them. The results will not only help children participate as active citizens and empower them as agents for change, but will transform our politics, our environment, our societies and the Europe of the future.









Become a #ChildRightsChampion

Future MEPs can ensure the EU delivers for children by:

- **1.** Re-establishing the European Parliament Intergroup on Children's Rights and working together with children, civil society and international organisations to build a more holistic internal and external agenda for children.
- 2. Ensuring the next long-term EU Budget invests in children and areas that impact them, particularly through Cohesion policy (European Social Fund + and European Regional and Development Fund), the Neighbourhood, Development and International Cooperation Instrument, the Asylum and Migration Fund, the Instrument for Pre-Accession Assistance and the Rights and Values and Erasmus+ programmes.
- 5. Making sure the EU adopts a Child Guarantee so that every impoverished or socially excluded child in Europe can access basic services.
- 4. Ensuring political parties engage with and listen to children by supplying childfriendly information about policies affecting them, providing opportunities for children to share their views and encouraging children to give feedback on the services they use.
- 5. Guaranteeing the new European Parliament promotes and protects children's rights regardless of children's origin or migration status.
- **6.** Ensuring the new European Parliament champions a comprehensive EU strategy on ending all forms of inequality, segregation, discrimination and violence against children, including girls and young women, everywhere.
- 7. Making sure the European Parliament stands up for foreign and domestic policies which respect the rights of children by providing comprehensive child protection systems, supporting the transition to family and community-based care, protecting children in conflict and investing in children so they can survive and thrive.
